Proxy Voting

- (1) any member of a company entitled to attend and vote at a meeting of the company shall be entitled to appoint another person (whether a member or not) as his or her proxy to attend and vote instead of him or her.
- (2) A proxy so appointed shall have the same right as the member to speak at the meeting and to vote on a show of hands and on a poll.
- (3) a member of a company shall not be entitled to appoint more than one proxy to attend on the same occasion.
- (4) The instrument appointing a proxy (the "instrument of proxy") shall be in the form provided below and signed by the appointer or his or her attorney duly authorised in writing
- (5) The instrument of proxy (and the power of attorney or other authority, if any, under which it is signed, or a notarially certified copy of that power or authority,) shall be deposited at the registered office of the company, and shall be so deposited not later than the following time.
- (6) That time is—
 - 48 hours (or such lesser period as the company's constitution may provide) before the time appointed for the taking of the poll.
- (7) The depositing of the instrument of proxy referred to in *subsection* (5) may be effected by communicating the instrument to the company by electronic means to eoghanogrady19@hotmail.com.
- (8) If *(5)* or *(6)* above is not complied with, the instrument of proxy shall not be treated as valid.

Proxies must bring one of the following photographic ID as proof of identity: <u>valid passport or valid drivers licence.</u>
